Some reflections about the program

As you know, the International Comparative Social Enterprise Models (ICSEM) is a project that began back in 2013. An initial group researchers from almost 50 countries joined during the initial stages and they have been conducting research in the last five years. We refer to this group as “wave 1” ICSEM countries. The COST Action EMPOWER-SE will allow to expand the initial impact of ICSEM by including new countries that join the Action. Since these new countries have recently arrived, we know them as “wave 2” ICSEM countries, and this first WG1 meeting aims at giving them priority to fully benefit from the previous steps and outputs of "wave 1", present their work and join the international research effort under the EMPOWER-SE Action.

For the first meeting of WG1, wave 2 countries will be divided into two groups in order to allow for enough time for all of them to present. Each group will include two types of presentations: countries whose representative researcher has submitted a written **paper** in advance, and those country representatives who have not managed to submit a draft paper but would like, however, to deliver a **short** presentation. The former will have a maximum of 20 minutes per country while the second will have 5-10 minutes per country.
