The University of Malta organises the Stakeholder Forum as part of the 3rd WG2 Research Workshop. This Forum aims to showcase the way cultural organisations and initiatives are engaging socially in Malta, as well as to propose a reframing of such initiatives within the wider social enterprise debate and challenges. In particular, the forum will look at the link between culture, arts and citizenship, and will critically discuss the positioning of such initiatives within the wider debates of the social and solidarity economy. This will include a reflection and dialogue on the economic dimension as pertaining to sustaining artistic and cultural expressions, while seeking to embed cultural and artistic dimensions in socio-economic relations.

The main format will be the sharing of experiences followed by an academic reflection and dialogue on such case studies. This format is in synergy with the main trust of the Research Workshop that seeks to help to create communities the construction of practices and narratives in spaces of diversity and citizenship. Such case studies will illustrate the diversity and wealth of local initiatives connecting culture, the arts and social enterprises, taking into particular consideration the local reality of a vacuum in any law that recognises social enterprises as such, as well as challenges pertaining to recognition, appreciation, access and clientelism. The Forum will also be interspersed with some readings that will illustrate the breadth of social challenges the country faces and how artists are seeking to engage and position themselves in front of such challenges.

Before getting started, we will dive, from a cultural policy/activist perspective, on some of the changes in the public sphere that are impacting cultural policies at the EC level. Particularly, we will reflect on how this change affects the possibility of developing social enterprises in the cultural and artistic field.

Secondly, based on the consolidation of neoliberal policies in Europe and the advance of some (far) right political programs, we will inquiry about the role left to civil society, in particular to organized civil society, and SE specifically, in the field of culture and the arts.

Lastly, given the multiple roles that cultural and artistic practices and movements assume and are attributed in contemporary societies, we will discuss how artistic and cultural initiatives driven by citizens can be supported to enact/implement their transformational potential.


